# Qualium Investissement announces the disposal of its stake in Constellation, expert in B2B IT solutions, to 3i

Paris, 13 May 2024 - Qualium Investissement announces the disposal of its stake in Constellation Group. Completion of the transaction, which remains subject to the approval of the antitrust and regulatory authorities.

Founded in 2016, in just a few years the Constellation Group has ranked among France's top 50 IT managed services provider.

Through its subsidiaries (the "Stars") and business divisions, the group offers a comprehensive range of digital services for SMEs, particularly in hybrid cloud and cyber-security. This offering is combined with innovative solutions in order to reduce the carbon footprint of IT systems. Based in Saint-Cloud (France), the group has 12 branches in France and employs 700 FTE. Its 2023(e) turnover is close to €200 million.

From the outset, Constellation has successfully pursued a strategy of external growth in a fragmented, deep market that is expanding steadily at 10% a year.

With the support of Qualium, which acquired a stake in Constellation in 2021, the Group has accelerated its buy-and-build strategy through 6 successive acquisitions: Clariteam and SecureWare (November 2021), CVC IT, BESTinfo and Dis (July 2022), and Hisi, a transforming acquisition (October 2022). These acquisitions have enabled the Group to extend its range of expertise, consolidate its position as sector leader and boost its growth. In less than three years, the Group has doubled its sales.

Strongly committed to sustainable development, the Group has set itself an ambitious environmental trajectory to halve its carbon intensity between 2021 and 2030. It strengthened its commitment this year by becoming a mission-driven company.

Etienne Besançon, Managing Director of Constellation, said: "We would like to thank Qualium, which has enabled us to consolidate our buy-and-build strategy and accelerate our development".
